Education + governance built in

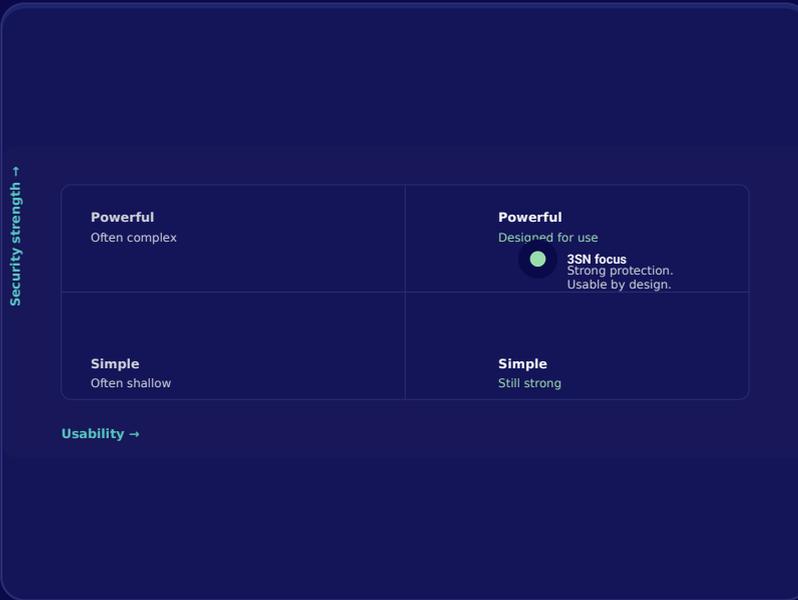


## Why this matters

Every interaction teaches. We strengthen the human layer of defense through contextual learning, not lectures.

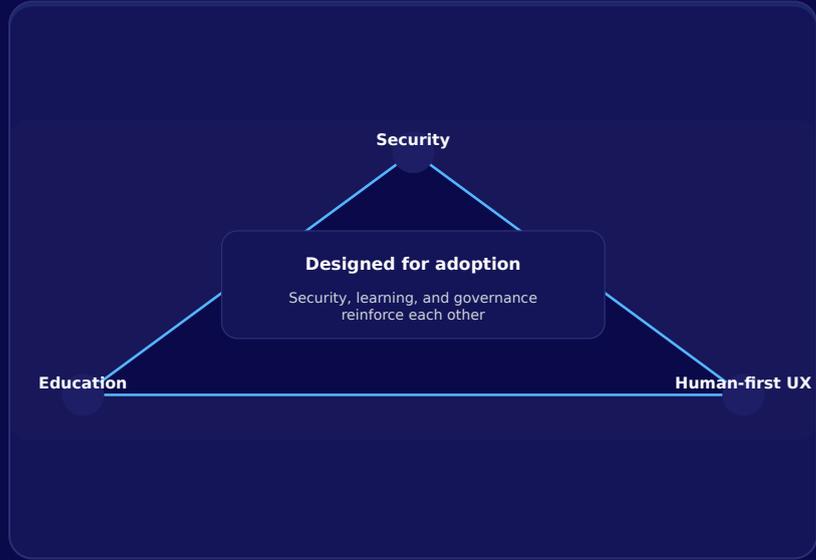
